COUNCIL TAKES

LEGAL ADVICE

REGARDING PUBLICATION OF INFORMATION TO HACKNEYS VOLUNTARY SECTOR

Following the publication of the article 'Voluntary Sector Training Budget - How the money was spent ' that appeared on the front page of the last edition of SPARK, HCA have been informed, by the LBH Community Development Unit, that the Council are in the process of seeking legal advice against HCA regarding an alledged breach of confidentiality. HCA have also been informed that this could have implications for its future funding position. A letter from the Community Development Unit marked ' Without Prejudice' also requests that the organisation should desist from releasing any further information relating to either 'bids' from Hackney Business Venture (HBV) and the London Voluntary Service Council (LVSC) details of which appeared in last months SPARK. The letter also states

that the individuals involved may also be held personally liable.

The basis of the allegation it would appear, is that HCA took part in a tendering process to select 'bids' for contracts.

However, the organisation had not been informed of this.

To date the organisation has not received any further correspondance regarding this matter either from the Community Development Unit or from the Council's own legal department.

In response the organisation has sought its own legal advice, and a solicitor instructed to act on our behalf. A letter strongly refuting the allegation has been sent and outlines that:

HCA attended a meeting of the Community Involvement Steering Group on 12 February 1993, to discuss three proposals for the use of funds from London Borough Hackney's voluntary sector training budget.

* That at no stage were HCA made aware that they were taking part in a contract screening or tendering process.

* That at no stage were HCA made aware that the status of the meeting had changed from that of a Community Involvement Steering Group to a contracts meeting.

* That at no stage was it made clear that the submissions that were actually discussed were actual bids as opposed to mere proposals.

* That at no stage was HCA made aware that either the meeting or its contents were subject to confidentiality. The letter also raises the issue that if details of the proposals were in fact tendering documents why were they sent through the post without any cover of confidentialitycont Page 3

That the terms of reference for the Community Involvement Steering Group do not contain a confidentiality clause. And more nportantly that HCA's role and emit within the borough and our attendance at the meeting precludes the fact that it could have been a tendering process.

Had a tendering process taken place, it would have been highly nappropriate for HCA to have aken part in it.

The letter also requests assurance that the organisation's future funding be not affected by the allegations and that the individuals 'concerned not be held personally liable.

What has not been mentioned in the letter but which is highly indicative of the implausibility of heallegation is that if HCA were taking part in a tendering process as assessor, how could we in this role also be tendering for a contract, after we had listened, commented on and made an assessment of the other supposed tenders. Wouldn't that be rather like being part of an interviewing and selection process as an interviewer, whilst also an applicant and interviewee.

HCA would clearly like to express to all concerned that we are not guilty of any alledged breach of confidentiality. It is in the interest of the organisation to work with and alongside the Council and other agencies for the benefit of its member groups. Whilst the organisation accepts that this can at times be a problematic relationship; since the needs of the Council and otheragencies are not always in accordance with, and in the best interest of those in the voluntary sector, we have endeavoured as

an organisation, to work in a manner that is contentious, professional and responsible. HCA continues to have an important information and monitoring brief within the borough, as this incident has revealed.

The organisation continues to work within the remit of its aims and objectives, and has not to its knowledge in this situation breached any condition of it's grant aid that would precipitate the withdrawal of its funding. An early, amicable and professional resolution to this situation is the ultimate aim of HCA.

TRAINING FOR **THE COMMUNITY** SECTOR - REPORT **TO COMMUNITY SERVICES COMMITTEE**

On 30 .3.93 a report originated by the Acting Head of CDU on training for the community sector was submitted to the Community Services Committee. The report recommended that members agree four proposals and that they waive standing order 85. with regard to the use of the Training Budget 1993/94

The report which is a public document outlines four proposals, which includes in addition to the 'bids' under dispute, a pre-emption of £10k for the Taskforce Quality Assurance Programme, and £10k for the delivery of a Training Needs Assessment for Hackney's voluntary sector, to be carried out by the Council own Training & Development Centre.

report, which was withdrawn from the agenda, is that the proposals are in respect of the training budget for 1993 / 94 (which is the now current financial year) and not 1992/93. This raises a number of questions, the most obvious being:

O.WHAT HAS HAPPENED TO THE VOLUNTARY SECTOR TRAINING BUDGET OF £40k FOR THE LAST FINANCIAL YEAR?

O. IF HCA, ALONG WITH A NUMBER OF OTHER **UMBRELLA** ORGANISATIONS, TOGETHER WITH A NUMBER OF OFFICERS FROM VARIOUS COUNCIL DEPARTMENTS, TOOK PART IN A STEERING GROUP AND CONSULTATION PROCESS, TO PROVIDE STRATEGIC **IMPUT TO THE** DEVELOPMENT AND SPEND OF THE VOLUNTARY SECTOR TRAINING BUDGET. WHY WERE WE NOT INFORMED THAT THERE WAS NO BUDGET?

Not only has the voluntary sector training budget of £40k disappeared, without any refernce, or explanation from either the LBH Community Development Unit who are responsible for the management of the fund, or Councillors who take ultimate decisions on change in spend, but that a Council Committee was presented with a report, that reccommends the waivering of Standing Orders in respect for the early release of monies, on 31. 3. 92 which falls within the 1992/3 financial year, for a financial year that had not even started, without question... continued on page 11

2% INFLATION

FOR COUNCIL FUNDED GROUPS 1993/94

At a meeting on 30/3/93
Members of the Community
Services Committee overturned
their previous commitment to
award direct grant funded
groups 4% inflation on their
1993/94 grants.

The cash limit for the Community Development Unit / Direct Grant Budget has been agreed at £8, 017,650 for 93/94, which includes a redirection of the Urban Programme budget to Policy and Resources and a virement to Leisure Services of £124,000. On this basis the budget was projecting an overspend of £61,176 and was £52,479 short of its Leisure Services virement.

Community development and grant aid is currently suffering as the poor relation to leisure on the spend of the Community Services Budget.

In order to stay within its cash limit, the Committee voted to reduce inflation on grants by 2%, achieving a saving of £60,390 (with £7,9111 uncommitted).

Although national wage awards look set to be between 1 - 1.5% this year, and this was a factor influencing Members decision, the voluntary sector is still faced with general depreciation and

rising costs which groups are already struggling to meet.
Lack of and low inflationary awards over a 5/6 year period has meant that voluntary organisations are feeling the cumulative effect of operating from hand to mouth.

HCA is particularly concerned at the inconsistency of decision making on this issue. Groups have already been informed, most of them in writing, that they would be getting 4% inflation in 93/94. At a meeting with the Chair of the Community Services Committee, Cllr Andy Buttress, HCA raised these concerns and stated that groups may have already committed expenditure on this basis (i.e. by leasing more expensive equipment). Cllr Buttress stated that if groups could provide evidence that this was the case they should inform CDU who would consider their needs in consultation with himself as Chair.. The Direct Grant Contingency Fund was quoted as a possible source of funds for getting such needs met.

CONTINGENCY FUND

HCA has made a formal request for information on the nature, conditions and application of the fund to LBH Community Development Unit.

DISCRETIONARY RATE RELIEF:

COUNCIL SET TO REMEDY ITS MISTAKES?

At a meeting with representatives from HCA, HCRE and the voluntary sector Premises Group on 30/3/93, the Chair of the Community Services Committee, Cllr Andy Buttress, stated that Members had acted in good faith in changing the way the Council funded rate relief to charitable organisations (see SPARK 153) but that they had clearly 'got it' wrong because groups were suffering'. He stated that this had never been Member's intention.

It was reported that a series of meetings had recently taken place between the Rates and Finance Departments and the Community Development Unit. who were looking to review and revise the new policy. An information gathering exercise is currently underway, and it has been agreed that in the meantime no deductions should be made from first quarter's grants. An emergency report considering the case of groups who have already lost out is to go before Members this week.

Councillor Buttress gave his personal assurance that groups would not be financially worse off when the new process was put in place.

NETWORKS BEFORE CONTRACTS COMMUNITY CARE AND THE COMMUNITY SECTOR

Now that April 1st has come and gone, and with it full implementation of Community Care, the Community Sector is still asking - will anything really change? And if it does, will it be for the better?

Social Services eligibility criteria are supposed to give people a clear understanding of the kinds of help they might expectn from the local authority. But with assessment such a close relative of how much money is available. we could easily end up with a non starter. Social Services have been given warnings about raising expectations through identifying unmet need. In fact Social Services departments across the country are bracing themselves for a wave of legal action from people who have been assessed to need a service! And even if this worse scenario doesn't become a way of life, there's still a lot of concern for people who really do need help but don't even reach the assessment stages.

Hackney Social Services
Community Care plan includes
what's described as 'open
assessment 'and 'negotiated
solutions'. But it's not been made
clear just how rationing resources
will be balanced with negotiated
settlements - and how users will
also help choose services they
won't have. SocialServices plan
to help - through open access
Advice and Information, through
Community Care Teams, whose
brief will be to create and
maintain community support

systems (the area where the voluntary sector is streets ahead), and through Care Management Teams - for people on the threshold of losing their independance and needing much more expensive residential support. In their latest Community Care Plan, Hackney's Social Services claim 'networks before contracts' as their key philosophy. The Community Sector Joint Planning Forum will be watching these changes - both in terms of user perception and in terms of community sector and representative organisations.

The Community Sector Joint Planning Forum's Contracts Working Group have been working on a 'Principle for Contracting' document, which aims to help Social Services include the community sector's vital input into care in the community. Community Care is supposed to change services to meet the needs of people who use them, rather than the needs of the people who provide them. Let's see if this does become the case.

Social Services have already started work to change grants to community sector organisations into contracts with them. There's a lot of nervousness though, because it's feared that active self help, advocacy and campaigning roles will get completely lost along the way (which would make it much more difficult to maintain a 'network before contracts 'approach). This could mean that it would be harder for

people to become involved as volunteer or unpaid staff, or as people working to develop their communities. Having contracts for care that clearly define roles and responsibilities, that clarify direction, and that offer a basis against which progress can be measured, could transform what's on offer into services that really do meet individual needs. Eventually Hackney's Social Services Department could spend a good deal more than it does now on working with local groups and charities to provide Community Care, but buying and selling community care isn't like buying or selling cars. The community sector and the privatre sector have been lumped together and called the independent sector in most recent 'bumph' from on high, but in reality they are two very different things. Support for local individuals and community development, and opportunities for people to help themselves and other people have been cornerstones of the community and not - for - profit sector . Will the private sector share these principles? And will value for money mean sacrificing quality for quantity.?

HACKNEY GROUNDWORK TRUST

A proposal to establish a Groundwork Trust in Hackney was presented to the Environmental Services Committee on 3.2.93. The Trust aims to provide a coordinating mechanism to take an overview of the strategic development of environmental action in the Borough. One of its key objectives is the development of active partnership between the local authority, the community and business.

It is proposed that the Trust be managed by a board of trustees. It is envisaged that 3 community representatives be nominated through the proposed Borough Environmental Forum. The Board will have two main functions:

- 1. To provide a forum for developing a strategic approach to Hackney's environment, and
- 2. To provide overall management of the Hackney Groundwork Trust as an operational agency. It is proposed that 4 staff be appointed to the Trust, comprising an Executive Director, Marketing/Outreach Co-ordinator, Contracts Manager and Administrator/ Bookeeper.

ON **URBAN** PROGRAMME

A report published by the Urban Programme Coalition estimates that the recent cuts to the Urban Programme will result in the loss of up to 9,900 community projects over the next three years.

The coalition, a 13 member umbrella body of national and regional bodies servicing networks of community and voluntary sector groups, have been formed to respond to the phasing out of the Urban Programme.

The coalition condemns the last minute scrapping of UP and calls for a reverse in the cuts for 1993/94. The coalition also demands that the Government provides transitional finance to help local groups maintain their services, pending the review of the Government's inner city programmes. A meeting with Micheal Howard, Secretary of State for the Environment, is being sought to discuss the impact on local communities. The meeting will also seek to raise a number of issues about urban regeneration policy.

The Comprehensive Estate
Initiative is a programme of
action to address complex
housing, social and economic
needs of five major 1960's system
built estates:

- Clapton Park
- Trowbridge
- Holly Street
- New Kingshold
- Nightingale

Over the next five years, each estate will undergo transformation based on the rehabilitation of current housing stock, new build housing and environmental improvements. This will be in tandem with diversification of housing tenure and management. To compliment these improvements, economic development initiatives and enhanced social facilities are to be provided.

The main element of funding for the initiative comes from a Partnership between the Council and Central Government via the Department of the Environment's Estate Action Programme, and the Housing Corporation. This is obviously for the housing elements of the programme.

An amount raised through the Council's capital receipts is also to be used for social and economic schemes on some of the estates (providing the Department of the Environment agrees). Bids for this funding have been prioritised by the

Council and were submitted to the DOE in late February /early March 1993.

The main aim of CEI is to involve and empower residents of the estates in as full a way as possible through the provision of technical support, organisational support, and communications.

The Council has also set up a network of Policy Working Groups to monitor achievement, develop new strategies and to draw together the relevant directorates working on the initiatives. The Working groups all report to the CEI Task Team, Chaired by the Chief Executive.

Further details of the proposed redevelopment of the five estates are held at HCA.

COMMUNITY ACTION PROGRAMME

The Government have recently introduced a major new Community Action Programme which aims to provide up to 60,000 opportunities for the long term unemployed, to work on projects run by voluntary organisations and other providers.

The Employment Service responsible for the operation of the schemewill be contracting with the voluntary sector. Participants will work part-time on projects and placements provided by voluntary organisations. Participants will receive an allowance of benefit equivalent plus £10 per week and job search support. The scheme is due to start in the summer, and is targetted at the 12 month plus unemployed.The Employment Service is committed to consulting with the voluntary sector.

The conference is to develop ideas on how 60,000 opportunities can be created and managed. NCVO have organised this conference to start planning how the voluntary sector can work with the Employment Service to deliver Community Action.

The cost of the conference per delegate is £30 for voluntary organisations and £60 for others. A limited number of reduced rate places are available at £10 for local voluntary organisations on a first come first serve basis.

The initiative raises a number of issues concerning the compulsory element of the programme, the nature of work to be offered and on whose behalf. Volunteering within the voluntary sector has never been seen as a cheap alternative to paid employment. voluntary activity that best serves the community depends on the energy and commitment of willing participants. Barbara Swift of St Helens CVS remarks in an article in TEN (Training and Employment Network news),

You cannot just throw people at the voluntary sector to provide opportunities; volunteers and organisations need support and a structure'

OUT-OF-SCHOOL CHILDCARE GRANT

The Government has allocated £45 million for the provision of Out-of School Childcare support to parents and guardians of school age children. The overall aim of the grant is to give parents and guardians the chance to participate more fully in the labour market, by improving the quantity and quality of childcare available outside school hours and during school holidays.

It is hoped this money will help set up around 50,000 additional out-of -school childcare places. The initiative will run over the next 3 financial years.

The grant will operate through Training and Enterprise Councils (TECs), who will develop local partnerships with other interested bodies in the community including employers, schools, parents, local authorities and voluntary organisations.

A variety of local initiatives could be supported such as after -school and holiday playschemes, childminder networks or school-based recreational and educational classes.

HACKNEY COMMUNITY **COLLEGE**

Hackney Community College was officially launched on 31 March 1993.

Platform speakers launching the college were: Susan Angoy, Hackney Task Force leader, Tim Boswell, Minister for Further and Higher Education, Councillor Andy Buttress, Chair of Hackney Community College Herman Ousley, Chair of the Commission for Racial Equality Bill Stubbs, Chief Executive Further Education Funding Council and Jerry White, Chief Executive London Borough of Hackney.

Herman Ousley judiciously signalled some of the challenges facing the College. It would have to meet high expectations on quality, whilst addressing the needs of multicultural communities. He reaffirmed his belief in the College's mission of no compromise, and urged it to go for the best. Herman outlined the equal opportunities targets he would set with the Further Education Funding Council (FEFC) to assist this achievement.

NON - ELECTED **MEMBERS** (CO-OPTEES) ON LBH COUNCIL **COMMITTEES**

A decision to retain nonelected members (co-optees) on LBH Council Committees was finally made on 22 March 1993 at Labour Group.

The status of co-optees, including community sector representatives, on committees has been under under review for two years. In 1991, LBH effectively barred community sector reps from participating on the Community Services Committee.

A clause which stipulated that community sector reps could only participate if they were neither employed by or on a management committee of any organisation funded by the committee, was introduced. The clausewas met with wide scale protestation from community groups in Hackney.

In January 1993 HCA submitted a report to labour group detailing why community participation on council committees was crucial. The report was well received.

Standing order (37/38) will now be changed on a number of committees; which in effect will mean the retention of co-optee status for community organisations on committees across the Council.

Further details of allocation will be published in a later edition of SPARK, following the release of the labour document.

SECTION 11 CAMPAIGN GROUP **HACKNEY**

A Hackney Section 11 Campaign group met for the first time on 25 March 1993. The setting up of a campaign group was one of the clearly identified objectives of the Section 11 Funding in Education Conference held on 27 February

The focus of the group is two fold at present:

1. To raise awareness among local parents and communities of the potential and limitations of S.11 funding, encourage their involvement in the process and promote necessary changes. 2. To lead a campaign on Section 11 funding in education and other areas, oppose the cuts and seek for a more equitable provision of S.11 funds.

As over 30 people attended this meeting, the group was able to split productively into two sections to devise strategies for the areas mentioned above.

Both groups agreed that getting information out to Hackney people had to be the first stage. The Campaign group will follow up with petitions, parliamentary lobbies and network with existing campaigns on S.11 The parent / community link group will liaise closely with schools and parents, build networks with other Section 11 workers, and sustain links through information sharing and closer collaboration to promote the necessary changes.

The group will meet again on 20 & 27 April. Contact Audrey West at HCA for details.

Three adventure playgrounds Holly Street, Homerton Grove and Shakespeare Walk presented a deputation to the Community Services Committee of 30 March 93, in protest at cuts which would make them disfunctional.

The speaker emphasised the value for money of the schemes, and the benefits to local children and Hackney people. The deputation was successful, and the total 35,000 cut was reinstated to groups.
